Getting to and from our airports

George Best Belfast City Airport is situated just three miles east of the city centre. A taxi costs just £10 and

there's also a shuttle bus service to the city centre every 20 minutes at £3 return. Belfast International Airport

is 30 minutes drive via the M2 Motorway. The Airbus service runs every 15 minutes between the Airport and

Belfast city centre (£11.50 return) and a taxi costs £27.

By Sea

Belfast is easily accessed by sea with crossings from both Scotland and England. Travel by state of the art

superfast ferries with journey times from just 2 hours 15 minutes. Operators and travel times vary. Please

check out Stena Line, P&O Irish Sea and the Isle of Man Steam Packet Company for travel options.

#### By Rail

An Enterprise service runs 8 times daily (5 times on Sundays) from Belfast to Dublin. The journey time is approximately 2 hours. T: 028 9089 9409. www.translink.co.uk

#### By Road from Dublin

From Dublin Airport, the M1 Motorway is well signposted for Belfast; this is a toll road and there is one Toll Plaza about 31 km from Dublin Airport. Continue on this Motorway signposted for Belfast. After passing the City of Newry, the road becomes a dual carriageway (A1) and Motorway regulations fall away. At the Sprucefield roundabout (approximately 137 km from Dublin Airport) the A1 joins the M1 motorway (sign-posted The North, Belfast). Once within the Greater Belfast area the signs will display as City Centre. At Grosvenor Road Junction (approximately 152 km) leave the motorway and follow signs City Centre onto the B38.

Belfast weather is relatively mild even in the winter with average temperatures ranging from 19°C in the summer to 2°C in the winter. Like most UK cities, the weather can be changeable so always best to be prepared and pack your umbrella and layers should you need them.

# Dialling codes

The international dialing code for Northern Ireland is 00 44 28 and the area code for Belfast is 90. The number for the emergency services is 999 and this will connect you to the police, fire, ambulance, lifeboat and mountain rescue services. Directory enquiries can be accessed by calling 118 500 or you can use online services for free such as Yell.com to search for contact details of local businesses and amenities.

#### Banking

The currency used in Northern Ireland is sterling (£) but some shops do except euro. Most banks are open on 9am-5pm Monday to Friday and all major credit and debit cards are widely accepted throughout the city. Foreign exchange facilities are available in the Belfast welcome centre, our tourist information centre.

# **VISAS**

#### Immigration and visa requirements

Northern Ireland is a constituent part of the United Kingdom, meaning it has exactly the same entry requirements as England, Scotland and Wales. Citizens of the UK and Crown Dependencies can travel to Northern Ireland without a passport and have the automatic right to reside and work. Once you are admitted into the UK from any other port-of-entry in England, Scotland and Wales, you can freely enter Northern Ireland within your time limit without going through passport control again.

- Citizens of the European Union do not require a visa, and have permanent residency and working rights in the UK.
- Citizens of Iceland, Liechtenstein, Norway and Switzerland also have permanent residency rights, but may require a work permit in some circumstances.
- Citizens of Argentina, Australia, Brazil, Canada, Israel, Japan, Mexico, New Zealand, South Korea, Taiwan, the United States and Uruguay do not require a visa for visits of less than 6 months.
- Most other countries will require a visa, which can be obtained from the nearest British Embassy, High Commission or Consulate.

- While there is no passport control on the land border between Republic of Ireland and Northern
  Ireland, visitors must still carry the required documents that permit them entry to the UK (passport,
  visa, identity card or documentation, depending on nationality).
- Most airlines insist on identification when flying, such as a driving licence or passport.
