# **Causation in Clinical Negligence**

This webinar will consider the issues of foreseeability which can arise in clinical negligence claims before moving on to consider "but for" causation and the alternative "material contribution" test. It will also consider some recent cases where causation issues have been addressed by the Court and discuss how the case of Chester v Afshar can be applied in practice.

David Dunlop QC was called to the Bar in 1998. He has a broad practice in clinical negligence claims acting for both Plaintiffs and for Defendants. He has had particular experience in obstetric cases and therefore has regularly had to consider many of the complex issues of causation which often arise in such claims.

# Surgical misadventures in the acute abdomen

### **Professor David Jayne**

David is Bowel Cancer UK & RCS Engl. Professor of Surgery at the University of Leeds and Hon. Consultant Surgeon at LTHT. He qualified from the University of Wales School of Medicine in 1989 and undertook higher surgical training in Leeds with overseas Fellowships to Singapore and the USA. His clinical interests include robotic and minimally invasive surgery for colorectal cancer and pelvic floor dysfunction. His is deputy Academic Programme Director for Surgery in the Yorkshire and Humber region. His research interests include the development of new surgical technologies and devices for minimally invasive surgery.

David is Clinical Director of the Leeds NIHR Medical Devices and in vitro Diagnostics Co-operative in Surgical Technologies. He has a growing research portfolio in International Health as Clinical Director for the Leeds NIHR Global Health Research Group in Surgical Technologies, which affords him the opportunity to apply his expertise in the clinical translation of surgical technologies to the context of low resource countries.
