## Directions

Parliament Square is off the Royal Mile in the centre of Edinburgh and a short walk from Waverley Rail Station, Princes Street and George Street.

Parking is available in the nearby NCP car park on Castle Terrace and within the Radisson Hotel on the Royal Mile or there is metered parking nearby. There is no parking available at the conference venue. Taxis are plentiful. Several bus routes pass the Royal Mile or the Mound.
