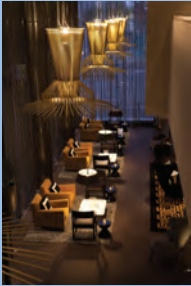


Accommodation Information

The Conference Hotel is the **Fitzwilliam Belfast**. Accommodation is available there at a preferential rate and a number of rooms are being held until the end of December 2016.
